


Did you know that Marshalltown has the best tasting drinking water in Iowa? It's true – two years in a row! The Marshalltown Water Works took top honors at the annual conference of the Iowa Section of the American Water Works Association (AWWA) in October of 2009 and 2008. A sample of Marshalltown's water will be sent to the AWWA national competition in June of 2010. Last year at the national competition Marshalltown finished in the top 10. This year we are reaching for the gold. These awards are the result of our dedicated employees who make sure you get the best water every day. The AWWA was founded in 1881 and is the authoritative resource on safe water providing knowledge, information and advocacy to its members. AWWA is global, 60,000 members strong, and advances the

public health, safety and welfare of drinking water consumers. The Marshalltown Water Works has been an AWWA utility member since 1984.

PARKER AVENUE WATER TOWER

Construction of the new water tower on Parker Ave has been completed. The new tower has a storage capacity of 500,000 gallons. The addition of the new tank brings our total elevated storage capacity to 2,800,000 gallons. The new water tower is scheduled to be placed into service in June. This investment by the Water Works will enhance the fire protection and reliability of our system.



BOTTLED WATER VS. TAP WATER

Did you know that your tap water costs \$1.42 per one hundred cubic feet? That is about the cost of a ½ liter bottle of Coke or bottled water. There are 748 gallons in 100 cubic feet of water. This is equal to 5,660 ½ liter bottles. So which would you rather have, 5,660 bottles of the best tasting water in Iowa, or one bottle of water from who knows where?

RECENT UPGRADES

The carbon dioxide feed equipment at our treatment facility was recently replaced. The new chemical feed equipment operates at a much higher efficiency than the old equipment. Thanks to this new chemical feed equipment, we will see a reduction in chemical cost.


DROP BOXES

The Marshalltown Water Works obtains a portion of its water from the Mississippian aquifer. The aquifer was determined to be not susceptible to contamination because the characteristics of the aquifer and overlying material prevent easy access of contaminants to the aquifer. The Mississippian wells will not be susceptible to most contaminant sources except through pathways to the aquifer such as abandoned or poorly maintained wells. For over 130 years the Marshalltown Water Works has been committed to providing the safest, highest quality, and most reliable drinking water. This report gives you an overview of our treatment process from the source to your faucet.

You will see that the contaminants detected in your drinking water are very minute compared to the standards set by the Environmental Protection Agency (EPA) Guidelines for Drinking Water.

The source of your water is ten deep wells located on the north side of the Iowa River drawing water from the Mississippian and Pleistocene Aquifers. The water is pumped to the treatment plant where it first goes through aeration to remove iron, radon, and hydrogen sulfide. It then travels to the softening basin for removal of the excess hardness and the remaining iron. The water is then pH adjusted and flows to the filters where it passes through the sand filters to remove the remaining very small particles. Chlorine is added as a disinfectant and fluoride is added to prevent tooth decay before being stored in the underground clear well. The water is pumped from the clear well to the distribution system for public use.

The Marshalltown Laboratory and Production Staff collect samples hourly at the water plant and daily from the distribution system at various locations around the City to ensure the safety and purity of the water supplied to you.

* If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Marshalltown Water Works is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. DEFINITIONS

Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) -- The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

ppb -- parts per billion.

ppm -- parts per million.

IMPORTANT HEALTH INFORMATION

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune systems disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline.

In order to ensure that tap water is safe to drink, EPA prescribes regulations, which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water that must provide the same protection for public health. Any bottled water that is labeled "drinking water" has to meet EPA's drinking water regulations. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants.
